The records of soldiers who fail a record APFT for the first time and those who fail to take the APFT within the required period (AR 350-15, paragraph 11) must be flagged IAW AR 600-8-2 (Reference B). (FM 21-20 pg 14-11) (2) Commanders may administer the APFT as often as they wish; however, they must specify beforehand when the results are for record.
