1. Completing the trust deed Once you have decided to apply to register a charitable trust, please read the trust deed and its accompanying guidance notes carefully. Some clauses contain blank spaces that you will need to fill in. The model is intended to be sufficiently flexible to deal with most eventualities.

It generally takes the form of a Trust when its is instituted or formed primarily by one or few persons only. In this guide, we only cover the procedure for forming a private Charitable Trust.

Charitable Trusts: Model Trust Deed (GD2)

In a trust where income is equated with the trust's net (taxable) income, a resolution distributing that part of the income attributable to a discount gain will only create an entitlement to 50% of the financial benefits that arise from the capital gain - that is, the discount component of the capital gain being non-assessable will not form part of the income of the trust.
