Use the Intensive Services Progress Note form to document other groups offered as part of programs such as Partial Hospitalization (PHP), Community Based Adolescent Treatment (CBAT) and Transitional Support Services (TSS).

Current Rule for Group Therapy. Group Therapy for SNF Part A residents has been defined by the RAI Manual as “4 residents performing same or similar activities, regardless of payer source,” since 1998. In 2012, the word “exactly” was added to require exactly 4 residents in a group. Medicare Part B residents have always been the exception to this rule, as Medicare Part B requires coding Group Therapy when 2 or more residents are treated together for any reason.
