**Georgia Department of Revenue**  
Form 500X is a Form used for the Tax Amendment. You can prepare a 2018 Georgia Tax Amendment on eFile.com, however you cannot submit it electronically. In comparison, the IRS requires a different Form - Form 1040X - to amend an IRS return (do not use Form 1040 for an IRS Amendment).

**Printable 2019 Georgia Form 500 (Individual Income Tax Return)**  
INSTRUCTIONS FOR PART-YEAR RESIDENTS AND NONRESIDENTS Part-year residents and nonresidents who work in Georgia or receive income from Georgia sources are required to file Georgia Form 500 and complete Form 500 Schedule 3 to calculate Georgia taxable income. Form 500 Schedule 3 should only be attached if it is applicable.

Georgia Form 500 is the state individual income tax return for Georgia residents. Georgia residents whose income for the tax year is more than the amount allotted for their standard deduction, which is based on filing status, must file Form 500. Residents required to file must do so on or before April 15 of each year.

Printable Georgia (GA) state income tax form 500 or form 500EZ must be postmarked by April 15, 2019 in order to avoid penalties and late fees. Printable Georgia state tax forms for the current tax year will be based on income earned between January 1, 2018 through December 31, 2018.
