When we talk about SBA Express Loans vs. traditional 7(a) Loans, the biggest differences are the amounts you can finance and the time it takes you to get the funds you need. Just like any other type of SBA loan, an SBA Express loan is a long-term loan that you can put to use on almost any expense for your business.

SMALL BUSINESS ADMINISTRATION EXPRESS LOANS

An SBA Express loan is a business loan backed by the Small Business Administration (SBA) that offers shorter turnaround and less paperwork than a standard SBA 7(a) loan. However, this means loan amounts are smaller, maximum interest rates are higher and the SBA often guarantees a smaller percentage of the loan you end up qualifying for.

SBA Express loans approved prior to March 27, 2020 may not be increased to a total loan amount of more than \$350,000. If the borrower needs additional funding, the borrower may request a new loan but the aggregate amount of Express loans may not exceed \$1 million in 2020. SBA Express is just one of many SBA loan programs available.

Economic Injury Disaster Loan (EIDL) The Small Business Administration COVID-19 Economic Injury Disaster Loan (the "EIDL Loan") is a loan directly from the SBA. This loan allows for up to \$2,000,000 with a term of 30 years and 3.75% interest. The application is complicated and requires a number of supporting documents.

Application Forms: SBA Form 1920 Lender's Application for Loan Guaranty. This form is completed by the lender. SBA Form 1919 SBA 7(a) Borrower Information Application Form. This form is completed by each owner with 20% or more owner of the company and kept in the lender's file after review for any adverse information.

A typical SBA Express Loan application will require the borrower to provide: Borrower application forms (including the SBA Form 1919) SBA Express Form Checklist. Plans for loan proceeds. Personal history statement (if applicant has a criminal history) Agreement of compliance (if funds are used for construction) An up-to-date profit and loss statement
